



All Party Continuing Care in Alberta Survey Results

On the Road to the Alberta General Election 2019

The Alberta Continuing Care Association (ACCA) is the recognized voice of Continuing Care (CC) in Alberta representing a unified and diverse membership who champion for quality of life, quality of care, and enhanced wellness for all Albertans requiring continuing care. This is Our Mission!

CC is a vital topic that touches every Albertan family in an intimate way. Our population is aging, and in fact it is super-aging with more seniors living 80+ years than ever before. Their health and safety needs are becoming increasingly complex and our province’s cultural diversity continues to evolve. Compounded with aging infrastructure and decades-old legislation, to provide the very best person-centred care in which we are sensitive to everyone’s unique needs and preferences, working in collaboration as a trusted partner with government is more crucial than ever.

ACCA presented the 4 main political parties (NDP, UCP, AP, Lib) with an outline of the challenges facing the CC industry, and recommendations on how, together, with the knowledge and support of our experienced and passionate membership, we can create the best sustainable CC industry possible.

We present below a high-level summary of the results of the survey so that voters know the parties’ policy intentions in this crucial 2019 provincial election.

Will you increase inventory, adding more choices for Albertans by creating or re-instituting financial programs that will support non-profit, faith based and independent operators? An AP led government recognizes that the current business model affects both the care and sustainability of our province's current inventory.</p> <p>The Ministry of Seniors in an AP-led government take a two-pronged approach. First it would request that the Auditor General of Alberta conduct a review of Alberta's current system and identify issues and opportunities. Since 2015 we have increased funding for home care by 29%, ensuring that more Albertans can leave hospital sooner and stay in their homes longer. Will you work with ACCA members to streamline regulatory, reporting, audits, capital planning and decision making for CC operators and CC residents and clients?	YES We are always open to innovations within government and we would be happy to work with ACCA members to find efficiencies and streamline operations in a way that preserves high quality service delivery.	YES A UCP government will streamline and modernize operations and cut red tape by 1/3 across the board. We believe there are a number of opportunities in CC to help the system focus precious time and resources on front line services.	YES The Ministry of Seniors within an Alberta Party-led government would take the lead in resolving these issues and providing one gateway for families and CC operators.	YES
Will you establish a comprehensive funding mechanism centred in a Ministry that ensures transparency in CC funding, leading to a clear understanding of costs across all operators (AHS, non-profit, faith based and independent) and make certain that cost of living increases intended to provide programs for CC residents and clients are indeed passed through to support programs for those Albertans?	We understand that all too often, CC can take a backseat to other demands within the health care system. However, since 2015 we have made significant improvements to CC, and we're committed to doing even more, including creating 2,000 new long-term care beds over the next five years. With regard to transparency, we have made significant improvements to transparency within government, and we are always looking for further ideas to build on that record. If re-elected we are happy to discuss improvements specifically to transparency around CC funding with you.	We would certainly be open to exploring these details further, but cannot commit to a specific funding model at this time. The lack of transparency of costs and parity of funding for different providers are things we can work with ACCA on as part of the overall AHS review we have committed to as part of the platform.	YES The Alberta Party's Shadow Budgets have identified our observation that our system of continuing care has duplication and likely a cost imbalance. Ultimately, cost imbalances result in unfair standards of care as they mean that funding is redirected to support a limited pool of residents, as opposed to a consistent level of care across the system. To provide better transparency and assist in developing better solutions, the Ministry of Seniors would request that the Auditor General of Alberta conduct an audit of the current state of Alberta's Continuing Care model, including identification of opportunities to improve the current system. <p>Will you delegate a Ministry to be directly responsible for the oversight, decision making, regulating and funding to all CC providers (AHS, non-profit, faith based and independent)?</p>	<p>The Ministry of Health is ultimately responsible for the funding and oversight related to the CC program in Alberta.</p>	<p>We would certainly be open to exploring this idea further, as clear governance is important for improving outcomes. Until the AHS review is done, however, we cannot commit to a specific governance and funding model at this time.</p>	<p>YES Yes, the Alberta Party has announced this as part of the election platform. <p>Will you support adding quality living space inventory to Albertans using the lowest cost providers and empowering local community partners, which may include Housing Management Bodies in rural Alberta?</p>	<p>Our priority in building housing is to ensure high quality living space for Albertans while getting the best value for Albertans' tax dollars. Balancing high quality and value-for-money is a key element of our approach to building housing for Albertans.</p>	<p>YES We have committed in our platform to returning to the ASLI model as well as alternative financing options, P3's, and also to permit more creative affordable housing options .
